ANNUAL MEETING

WATER WISE LANDSCAPING

The board is preparing an amendment to the CCRs that would allow rock in park strips. You will be notified when the amendment is ready for you to vote on. If the amendment passes the board will move ahead with proposing Water Wise Park Strip Landscaping Rules to the HOA. The board will keep up to date on the progress of these changes. The HOA Board supports efforts to conserve water while maintaining consistent and aesthetically pleasing landscaping.

You are required to clean up your dog's poop. Do the right thing and clean up after your dog. Keep dogs on leash.

APPROVAL FOR PROJECTS

There are several projects that require HOA approval. Those include changing the exterior color of your home, concrete pads on the side yard, pools, and anything that requires a building permit. Please email James, the HOA manager, to start the approval process for any of these projects.

PARKING RULES AND REGULATIONS

Trailers, mobile homes, travel trailers, boats, campers, motor homes, buses, tractors, and maintenance or commercial vehicles are not allowed to be parked or stored on any streets or driveways. They are allowed to be parked or stored behind the front yard setback.
